Gospođa Kosor zatražila je od Ministarstva gospodarstva mjerodavno postupanje, no to do danas Ministarstvo nije učinilo.

Nedugo nakon moga pisma od 12. ožujka o.g. upućenog Primorcu, isti je najavio svoj odlazak, mada vjerujem da su kumulativno i drugi razlozi tome pridonjeli.

Inače, Topićevo ukidanje Sektora za autorsko i srodna prava (i moga radnog mjesta pomoćnice ravnatelja) protivno je pisanim preporukama stručnjaka iz EU, danim kroz 2 CARDS projekta, poglavito onog koji se je odnosio isključivo na autorsko i srodna prava (ugovor br. 96-022), koji projekt, kako sam čula, je realiziran temeljem upravo Vašeg prijedloga. Ukratko, Topić je izignorirao struku i novac koji je EU uložila po tom pitanju u Hrvatsku.

Dear Mr. President,

I would like to suggest that we meet in order to make you familiar that your presidential competitor, Dragan Primorac had received from Željko Topić the amount of around 500,000.00 Croatian kuna , during the period of two years, that is represents the criminal act of taking and receiving the bribe. This is mentioned inside the constitutional petition, that is enclosed herewith.

Mrs. Kosor had requested from the Ministry of Economy to undertake necessary steps to initiate the proceedings, which until today was not done.

Not a long time after my brief of March 12th, of this year addressed to Mr. Primorac, he had announced his resignation, though I believe that other reasons had contributed, too.

The elimination of the Sector for Copyright and Related rights that had Topić initiated (and of my position of the Assistant Director) is in contravention of the written recommendation of the professional experts from the EU, given through two CARDS projects, especially the one that related exclusively to the copyright and related rights (Agreement number 96-022). I had heard that this project was realized exclusively on your proposal. All in all, Topić had ignored the profession and the funds that the EU had invested into the Republic of Croatia. I shall explain it in detail during our meeting.
